## Comprehensive Community Behavioral Health Provider Update...

All behavioral provider groups that will require updating their records with new billing NPI data in response to the Comprehensive Safety Net Provider changes within the Colorado Dept of Health Care Policy & Financing will need to see below:

If new NPI billing numbers are required, access the Community Provider Portal: Provider Information | Community Provider Portal | Kaiser Permanente, then navigate to the Provider Demographics section and download the Service and Billing Office Adds-Changes-Terms Template. Complete the "Office Adds Term" tab and the "Link Practitioners" tab. Return the template to kpco-pdm@kp.org for processing.

## **Use of Al during Provider Meetings**

The Provider Experience Team would like to inform you that we have recently observed network providers and provider groups using AI note-taking software during meetings. In some cases, the AI software has been attending meetings and training sessions in place of the provider group team. One of our responsibilities is to help ensure providers adhere to HIPAA guidelines and regulations, and to safeguard PHI by ensuring patient data is protected from unauthorized access.

To ensure compliance with HIPAA guidelines, the use of AI software is **not permitted** in the following settings:

- JOCs
- AFL Trainings
- Behavioral Health Provider meetings
- Quality Collaborative meetings
- Any meeting that may display patient health information

## Use Affiliate Link to place Imaging and Lab Orders when sending members to Kaiser Medical Office Buildings

All providers should be utilizing the Affiliate Link for a seamless process when sending Kaiser members to a Kaiser Medical Office Building for Medical Imaging and Lab services. When orders are entered via Affiliate Link, transcription errors are greatly reduced. Additionally, AF Link communication helps in reducing delays for patients to receive their care.

Furthermore, members coming to a KP clinic can schedule most Medical Imaging exams online if the order is in the KP system, placed there by the provider using Affiliate Link. This ensures a smoother and more efficient experience for both providers and patients.

For those who **do not yet have access to Affiliate Link**, imaging orders can be faxed to 1-855-416-3847, and lab orders to 1-877-489-5586. This should be done at least 48 hours before the member plans to go to the Kaiser Medical office radiology department or lab for testing.
