Here's a look at the benefits and services that are covered for transgender members and an overview of how our care delivery teams support you through your care journey.

It starts with primary care

If you are considering hormone therapy or gender confirmation surgery, the first thing you should do is visit your primary care physician – someone who not only understands your medical history but also knows you as a person.

Connecting with a care team

From there, the primary care physician may introduce you to specialists and other caregivers familiar with unique challenges of transitioning. Care teams collaborate to provide medical, psychological, and emotional support throughout the process.

What's covered¹

Based on medical necessity for the treatment of gender dysphoria, coverage for fully insured plan members includes mental health therapy, hormone therapy, mastectomy, gender confirming lower-body surgeries (male-to-female and female-to-male), tracheal shave, and facial hair removal.² You can find a detailed list of covered services on the next page.
