## **RBRVS Fee Schedule Revisions**

It is the policy of Kaiser Permanente of Georgia's Provider Contracting and Network Management Department (PC&NM) to review and update the fee schedules only once annually. Unfortunately, after this process was completed, Congress and CMS altered the RBRVS Conversion Factor. As such, the fee schedules are under revision and will be updated as soon as possible.

We apologize for any confusion or potential changes in payments. This is a one-time revision due to extenuating circumstances and will not be a quarterly or annual thing. We will continue to only update our fee schedules once annually moving forward.

The KP Market Fee Schedule (KPMFS) is also subject to review and update annually. A copy of the KPMFS schedule is posted on Online Affiliate, which you can access from www. kp.org/providers/ga, but the new version will be effective June 1st.

### **Accurate Provider Directories**

## **No More Than 10 Addresses**

Due to Federal and State requirements, and increased scrutiny on accurate provider data and directories, we cannot publish your providers at locations that are not reflected on your website.

Please send us an updated roster of providers and their regular practice locations that reflects only what is published on your website.

CMS will no longer allow more than 10 addresses per provider as they conveyed that providers are not able to cover that many locations on a regular basis. Again, please send us only the locations where providers routinely, regularly are available via office based appointments.

## **New Provider Demographic Roster/Update Template**

To further ensure complete and accurate provider data and directories, Kaiser Permanente of Georgia will be implementing a new mandatory data submission template effective June 15th, 2023, with several groups already utilizing the tool. New fields include but are not limited to Medicaid Number, Telehealth options, Practice Age Restrictions, and Group Email and Website.

Additionally, all data/demographic communication needs to be directed to <a href="KPGA-PDM@kp.org">KPGA-PDM@kp.org</a> in addition to your current KPGA Provider Contracting contacts. If all data fields are not completed for a provider/facility, then that provider will be returned to you for the additional information and will not be effective until all data fields are completed.

Per your contract and the provider manual, you are required to submit accurate provider demographics and data. You are also required to provide advanced, timely notice of any changes including terminations, at least 30 days before the effective date.

In line with KPGA Policy, we will continue to add providers and/or addresses with future effective dates. We will not add providers or addresses using past effective dates. All effective dates will be the future date of the 15th of the current month, or the 1st of the following month. For example, if the demographic updates are received by KPGA on the 15th of February, the effective date will be the 1st of March.

Reminder, providers cannot see KPGA members until after their effective date, or their claims will be denied.

Medicare Part D Benefit Coverage – Product Additions/Removals/Changes
During the year, Kaiser Permanente may make changes to our Medicare Part D Formulary (Drug List).

For product removals, affected members who were prescribed these drugs prior to the removal effective date will receive a one-time 30-day Transition Benefit (TB) fill. For the members to continue receiving the medication for the remainder of the year, a medical necessity override will be required.

For prior authorization additions, these changes will apply to new starts only – affected members will be grandfathered.

With this partnership, Kaiser Permanente requests that all vendors pursuing EFT/ERA enrollments utilize the Payment Exchange portal for enrollment and changes to existing EFT/ERA. The portal is open 24 hours a day and 7 days a week for new enrollments or changes.
