- Prescribed by neurologist AND
- Patient is at least 18 years old AND
- Prescribed for the treatment of acute migraine OR migraine prophylaxis AND
- Documented past medication trials as outlined below:
 - o Acute migraine:
 - Patient has failed a trial[^] of or has an allergy or intolerance to at least 3 triptans at maximum tolerated doses OR patient has documented contraindication to triptan use (i.e. coronary artery disease, history of ischemic stroke due to atherosclerosis, peripheral vascular disease, uncontrolled hypertension) AND
 - Patient has failed a trial of or has an allergy or intolerance to ubrogepant (Ubrelvy)
 - Migraine prophylaxis:
 - Patient has failed an adequate trial of, or patient has an allergy or intolerance to 3 additional preventative agents for migraine, 2 of which must include: tricyclic antidepressant (amitriptyline or nortriptyline), or beta-blocker (metoprolol or propranolol), or valproate, or topiramate AND
 - Patient has failed a trial of, or has an allergy or intolerance to fremanezumab (Ajovy), AND galcanezumab (Emgality) AND erenumab (Aimovig)
 - Patient has failed a trial of, or has an allergy or intolerance to atogepant (Qulipta)
