Dental health is an important part of your overall health. That's why our Medicare health plans include a preventive dental care benefit through Delta Dental of Washington.

If you want comprehensive dental coverage, you can replace the preventive dental benefit with the optional supplemental Delta Dental PPO Plus PremierTM plan for \$52 per month. (This amount is added to your Kaiser Permanente Medicare health plan's monthly premium.)

With Delta Dental coverage:*

- Choose from a large national network of dentists
- Get full coverage for semiannual dental checkups and coverage for restorative care, such as fillings, root canals, and crowns
- Save money on dental treatments from a network of dentists who offer preapproved, discounted fees

How to enroll



If you're enrolling in our Medicare health plan, simply answer "yes" in the optional dental plan section of our Medicare Advantage individual plan enrollment form.



If you're already enrolled in our Medicare health plan, call Member Services at 1-888-901-4600 (TTY 711), 8 a.m. to 8 p.m., 7 days a week, and enroll during one of these time frames:

- Within 30 days of your health plan's start date
- Between October 15 and December 31 (coverage will start January 1)
- Between January 1 and March 31 (coverage will start the first of the month following receipt of your enrollment)

NOTE: If you enroll in the optional Delta Dental PPO Plus Premier plan, the preventive dental care coverage it provides will replace the preventive dental care benefits included in your Kaiser Permanente Medicare health plan.
