What is the overall deductible?	\$0	See the Common Medical Events chart below for your costs for services this plan covers.
Are there services covered before you meet your deductible?	Not Applicable.	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost sharing and before you meet your deductible . Are there other deductibles for specific services?	Yes. \$100 Individual / \$200 Family for specialty prescription drugs . There are no other specific deductibles . This plan uses a provider network . You will pay less if you use a provider in the plan's network . Be aware, your network provider might use an out-of-network provider for some services (such as lab work). Check with your provider before you get services.
