If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible . |
| Are there services covered before you meet your deductible ? | Yes. Preventive care and services indicated in chart starting on page 2. | This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost sharing and before you meet your deductible . | Are there other deductibles for specific services? | No. | You don't have to meet deductibles for specific services. |

If you have other family members in this plan , they have to meet their own out-of-pocket limits until the overall family out-of-pocket limit has been met. |
| What is not included in the out-of-pocket limit ? | Copayments on certain services, premiums , and health care this plan doesn't cover. | Even though you pay these expenses, they don't count toward the out-of-pocket limit . |

You will pay less if you use a provider in the plan's network .
