<b>What is the overall <a href="#">deductible</a>?</b>	<a href="#">Plan Provider</a> : \$2,500 Individual / \$5,000 Family; <a href="#">Non-Plan Provider</a> : \$4,500 Individual / \$9,000 Family	Generally, you must pay all of the costs from providers up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a> .
