What is the overall deductible ?	\$0	See the Common Medical Events chart below for your costs for services this plan covers.
Are there services covered before you meet your deductible ?	Not Applicable.	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost sharing and before you meet your deductible . What is the out-of-pocket limit for this plan ?	\$2,000 Individual / \$4,000 Family	The out-of-pocket limit is the most you could pay in a year for covered services. What is not included in the out-of-pocket limit ?	Copayments on certain services, premiums , and health care this plan doesn't cover.	Even though you pay these expenses, they don't count toward the out-of-pocket limit .
