# Recall of NP Thyroid 30 mg, 60 mg, and 90 mg Tablets by Acella Pharmaceuticals

Dear Kaiser Permanente Member,

You may be affected by a recent recall of NP Thyroid 30 mg, 60 mg, or 90 mg Tablets manufactured by Acella Pharmaceuticals.

If you are no longer taking this medication or no longer have a supply of this medication, please ignore this letter. If you have a supply of this medication, here is what you need to know about this recall.

### Why is Acella Pharmaceuticals recalling this medication?

- Acella Pharmaceuticals announced the recall because multiple lots (batches) of this
  medication contained potentially *higher* amounts of drug than expected.
- Acella Pharmaceuticals issued the recall to assure the health and safety of people who take this medication.

#### How do I know if my medication is affected by this recall?

- If your prescription was filled with a traditional "amber" (brown) prescription bottle, you will need to call the pharmacy that fills your prescriptions to discuss exchanging your medication at no charge.
- If your prescription was filled with the manufacturer's original "white" bottle, you may be able to find the lot number and expiration date.
  - The lot number and expiration date are printed on the manufacturer's label (not the label the pharmacy typed).
  - If your bottle is printed with a lot number and expiration date listed in the table below, your medication has been recalled.
  - Please call your pharmacy and discuss exchanging your medication with your pharmacist. The pharmacy's phone number is found on the prescription label.
  - o If you can't find the lot number and expiration date, call your pharmacy to discuss exchanging your medication.

#### What other things do I need to know about this recall?

- Do not stop taking your medication, this is not an emergency.
- Do not bring your remaining prescription back to the pharmacy.
  - o Mix the tablets with something undesirable, such as coffee grounds, dirt or cat litter.
  - This makes the medicine less appealing to children and pets.
  - Put the mixture in something you can close (a re-sealable zipper storage bag, empty can, or other container) to prevent the drug from leaking or spilling out.
  - Throw the container in the trash.

## What should I do if my medication is not from the recalled lot?

• If you are able to identify the lot and expiration and your bottle is **not** from a recalled lot listed in the table below, your medication is **not** affected by the recall and you may continue to use your medication.
